3. Ten percent (10%) term consideration shall accompany each bid in the form of a Cashier's Check, Money Order, or Letter of Credit from bidder's financial institution and will be subject to forfeiture for failure to comply with bid. NEITHER CASH OR PERSONAL CHECK WILL BE ACCEPTED.
4. The Tensas Basin Levee District shall accept the highest responsible bid that meets or exceeds the minimum bid set and reserves the right to reject any and all bids and to waive any informality.
